Ireland's Best kept Town 2019

The awards ceremony for the 2019 Ireland's Best Kept Towns took place on June 25th in Farmleigh House in Dublin.

This year Ballymacarbry, Co. Waterford and Silvermines, Co. Tipperary were finalists in the village category, Ballymore Eustace, Co. Kildare and Bantry, Co. Cork were representing the small town category with large town category entries form Ardee, Co. Louth and Arklow, Co. Wicklow. The finalists for the large urban centre category were Wexford. Co. Wexford and Galway City Centre.

We had a great turn out from all our TidyTowns finalists together with six finalists from the Northern Ireland's Best Kept competition. The awards were presented by Mr Kevin Mc Carthy Secretary General of the Department of Rural and Community Development who administer the SuperValu TidyTowns, Mr Dave Foster from the Department of Agriculture, Environment and Rural Affairs in Northern Ireland and Ms Doreen Muskett MBE, President of the Northern Ireland Amenity Council.

Bantry were crowned as Ireland's Best Kept Small Town while Arklow were named as Ireland's Best Kept Large Town. Other winners included Donaghmore in County Tyrone in the Village category and Bangor in County Down in the Large Urban Centre category

This coming week judges from countries across Europe will visit Listowel in Kerry and Mulranny in Mayo as they are the Irish finalists for the Entente Florale Europe competition for 2019. Entente Florale is a Europe wide competition and aims to encourage the development and maintenance of green spaces, parks and landscaping in harmony with our natural and built environment. It also promotes awareness of green issues through education and through the development of environmental and green polices to improve the quality of life for all inhabitants. Each year Ireland put 2 entrants forward and we have been very successful to date having received over 45 medals. Over half of these have been at Gold standard. We wish the committees, Local Authorities and all involved in both centres the very best of luck for their Jury visits this week. The results will be announced in Austria in September, we will keep you updated on how our Irish entrants do this year.

The awards ceremony for 2019 will be held in The Helix on Monday September 30th. This is an invitation only event, invitations will issue in September. Results books and copies of your 2019 Adjudication report will issue to you on October 1st but will be available to view from 1:00pm on Monday September 30th on our website; www.tidytowns.ie.

The Community Foundation for Ireland's Environment and Nature Fund 2019 is now open for applications.

A fund of €100,000 is available to projects which focus on creating Sustainable Communities through the Circular Economy and Sustainable Consumption and Waste.

The fund is open to community groups. There are three strands within the scheme, as follows:

Strand 1: Grants of up to €3,000 to develop a Community Action Plan focused on reducing consumption and waste in the areas of food waste, plastic and packaging, clothing/textiles and electrical items.

Strand 2: Grants of up to €5,000 to support community groups to trial new and innovative approaches around reducing consumption and waste in the areas of food, plastic and packaging clothing/textiles and electrical items.

Strand 3: Grants of up to €10,000 to support community groups to grow current small scale initiatives to reduce consumption and waste in the areas of food, plastic and packaging, clothing/textiles and electrical items that reach a larger number of users and could act as a viable demonstrator for other groups.
