# Communities in Bloom 2019

Malahide participated in the International Challenge Medium category along with Leighton-Linslade in Bloom UK; Mosonmagyaróvár Hungary; Nivelles Belgium and Stratford in Canada.

On Saturday September 28<sup>th</sup> in Haus in Austria a great night of celebration took place when the results of the 2019 Entente Florale competition were announced. Both Listowel and Mulranny did us all proud and walked away with a Silver medal each. In addition to the medals, Mulranny received the President's award for the Old Irish Goat project. Both Mulranny and Listowel also received special certificates for projects they had presented to the Jury during their visit. Childers Park in Listowel were noted,

as too was the environmental approach of the Green Plan Team in Mulranny. Congratulations to both centres for representing Ireland to a very high standard on the European stage.

# 2019 TidyTowns Grant Funding

At the announcemnt of the 2019 awards back in September, Minister Ring announced a funding package of €1.4 Million for TidyTowns groups. To be eligible for this funding a TidyTowns committee would have had to have entered the competition in either of the last three years, i.e. 2017, 2018 or this year 2019. Funding of between €1,000 and €4,000 is available depending on the size of your centre. Letters have issued to all eligible groups, we would encourage you to compelte the application form and return it to Pobal, who are administereing the funding on our behalf. When completing the form please do not reference any other projects you are involved in only those that you propose to complete as part of the funding. So if you qualify for a grant of €1,000, only include projects to the value of €1,000.
