WELCOME

Dear TidyTowns Committee,

Welcome to our second newsletter for 2020, what a strange couple of months it has been since we were in touch with you last. As a result of the Coronavirus (Covid-19), which has very much been part of our lives for the last 2 months, the SuperValu TidyTowns competition has, unfortunately, been cancelled for the first time in its history.

Coronavirus (Covid-19)

COVID-19 is a new illness that can affect your lungs and airways. A virus, called coronavirus, causes it. Coronavirus is spread in sneeze or cough droplets. To infect you, it has to get from an infected person's nose or mouth into your eyes, nose or mouth. This can be direct or indirect (on hands, objects, surfaces). The current public health advice is to stay at home and to protect ourselves through proper hand hygiene, sneeze and cough etiquette and in cleaning surfaces regularly. 2020 Competition

On April 21st, Minister for Rural and Community Development, Michael Ring T.D. issued a statement cancelling the 2020 competition due to Coronavirus (Covid-19). In the statement, Minister Ring said, "For over 60 years the SuperValu TidyTowns competition has captured the imagination of communities the length and breadth of the country. Generation after generation of local volunteers have given their time generously to make the SuperValu TidyTowns competition the success it is today", he went on to say, "For me, the health and welfare of the volunteers on the TidyTowns Committees is paramount. Given the current restrictions around public gatherings, travel, and adherence to social distancing, it would not be appropriate to ask voluntary groups to work on SuperValu TidyTowns projects in their communities at this time".

Martin Kelleher, Managing Director of SuperValu, who have been sponsoring the competition for 29 years said, "Having supported the SuperValu TidyTowns competition for almost 30 years to date, we know how disappointed committees around the country will feel as they learn that this year's competition is cancelled. Rest assured, TidyTowns' volunteers' relentless efforts are now being enjoyed by many as they safely explore the two kilometres around their homes. I would like to publicly thank all of the volunteers for always standing tall and working tirelessly to make our towns and communities flourish"

Given the Europe wide participation and the Jury visits, it was decided to cancel the competition entirely for 2020. Carlow Town and the village of Keadue in County Roscommon were our Irish entrants for the 2020 competition. These two centres will now represent Ireland in the 2021

competition and we wish them every success in their entry.

Ireland's Best Kept Competition 2020



Ireland's Best Kept competition is a North-South initiative and is in place since 1995. This year, 2020, we were to celebrate the 25th anniversary of this all-island competition. The awards ceremony was scheduled to take place in Belfast on June 23rd and we were delighted to put the

following centres forward for the 2020 adjudication; Abbey, Co. Galway, Inistioge, Co. Kilkenny, Abbeyleix, Co. Laois, Birr, Co. Offaly, Raheny, Co. Dublin, Tramore, Co. Waterford, Athlone, Co. Westmeath and Dundalk, Co. Louth. Whilst these towns and villages did not get the opportunity to impress the judges this year, we are delighted to say that they have all agreed to represent their categories in the competition next year. Communities in Bloom 2020

Ireland's Tidiest Town for 2019, Glaslough in County Monaghan were to represent their country in the 2020 competition. researched the story. The local Tús group added the stonework and a recycled plastic bench was purchased. When the project was completed, the group were delighted to welcome Michael Ring, T.D. Minister for Rural and Community Development to unveil the project.

Kilbride TidyTowns, Co. Meath


We received a heart-warming message from Denis O' Leary and all in Kilbride TidyTowns. They, like many other groups had great plans to have a Float in the St. Patricks Day parade. After working with the local school "Scoil Bhride" they were all ready with colourful artwork relating to the TidyTowns competition and, in particular, brightly coloured butterflies and bees in line with biodiversity messages. Unfortunately, it was not to be, due to the Covid 19 restrictions taking effect a few days before the parade.



The group decided, to place the brightly coloured butterflies around the village to brighten it up for the residents and those that were walking through for their daily exercise as the lockdown continued. This created great interest and positive comment by all in the area.

Like many other voluntary groups, Kilbride TidyTowns were not for sitting idle. They considered how they could assist their community and decided to acknowledge the huge efforts of the Frontline Healthcare workers and

discovered that from their small village and surrounding area there were 16 individuals working in 8 different hospitals and in local medical centres and the ambulance services.



The group decided that it would be nice to treat these frontline workers to a surprise token gift to brighten up their days and to acknowledge their massive effort and commitment. They made up a gift of a Thank You card and message, flowering plant, homemade colourful butterfly, a solar light and a packet of Rolo sweets and delivered them to their doorways and gateways on the 24th April. The reaction from all was brilliant to see, many getting them just before going out on night duty, some receiving them the following day after returning from tours of duty, exhausted. The news travelled to their colleagues who sent many messages of thanks to Kilbride TidyTowns.

What a wonderful way to turn the disappointment of the parade cancellation into such a positive and brightening up someone's day. Well done to all involved.

Placemaking Awards 2020

The 2020 Excellence in Placemaking Awards competition is open to all public and private organisations as well as community groups in each Province of the country and entry is free. Green Winged Orchid – Co Laois

Dr Mark McCorry & Dr Fiona MacGowan, BSBI Botanical Recorders for Co. Laois have some exciting news for us. You might ask, does the Covid19 lockdown have any silver linings? Well, one was seeing the motorway verges covered in Dandelions and Cowslips on a recent trip to Newbridge. The delay in routine mowing along the motorways has allowed these wildflowers to flourish providing stunning carpets of yellow – a joy to both the human eye and our hungry pollinator species.

A rare wildflower species has also recently appeared on a grassy verge in a Portlaoise housing estate. Green-winged Orchid (Anacamptis morio), was recently recorded by Brian Gaynor, the Laois-Offaly IWT chairperson and environmental consultant. This orchid is particularly rare, only having been recorded at three other locations in Co. Laois in recent times.
