2021 SuperValu TidyTowns Competition

Following on from the commitment to hold the competition this year, the Department and our sponsors are preparing for this. It had been our intention to launch the competition in late March but timelines this year will be directed by where we are as a country with the pandemic. The health and safety of you, the volunteers is paramount to all of our decisions and we will only take steps to launch the competition when we feel it is safe to do so. We await updates due on March 5th, we will review the situation at that point and will keep you updated through the newsletter and through social media.

As we wait for the competition to launch, these weeks can be used to work on the map of your town or village, remember a hand-drawn map is fine, once it shows the projects you are submitting in your entry form. These can be new projects, maintenance projects and of course future projects that will have been listed in your TidyTowns 3-year plan. It's a good idea to check the 2019 report that issued, maybe the Adjudicator made a comment or a suggestion regarding your map.

Bringing us on to the TidyTowns 3-year plan, this is an opportunity to review many of the projects you had identified and listed in previous years, they may not have progressed for one reason or another, perhaps lack of funding or support, perhaps it was as a result of the pandemic and that is fine, whatever the reason was. Simply note that it has not progressed and if you still intend to proceed with it when time and resources allow, continue to include it. It is also worth mentioning the maintenance projects you are working on in your 3-year plan. You do not need to go into detail on these as they will be recorded in your entry form but all the same, it is still part of your overall plan going forward to maintain what has been developed in the past.

We acknowledge that these past months have been a struggle and continue to be so. If for any reason a group feels that they cannot enter the competition this year that is fine, rest assured there will be no negative marking for not entering, we will welcome you back next year and be delighted to have you back in the competition.

We would encourage everyone to enter, we are all in this together and if you have not been in a position to progress any projects, we would still love to hear from you on how your group stayed in touch and kept the community going through the last year. A united group will emerge from this strong and will bring their community forward; you may have been instrumental in the Covid-19 community forum or checked in on elderly residents, these are the things that will keep the community united, you may not realise it but you have played a huge role in helping people through these difficult times. We want to hear from you.

The TidyTowns unit will continue to share information with you through our monthly newsletters. We are going to start a "Questions and Answers" section too, so if you have a question, send it in, maybe others are wondering about the same topic. We will feature your questions each month. We also plan on doing a webinar next month, which will be available on the website, stay, connected for more information.

Glounthaune TidyTowns - Cork

A fund to "enhance the public realm and infrastructure" of villages in County Cork was announced in 2017. Glounthaune lobbied strongly over a number of years and the €62,500 grant was eventually obtained in 2019 from Cork Co. Co., Cobh Municipal District. The previous recipients of the grant were Glenville 2017 and Carrignavar 2018. This was a 100% grant with no community contribution required as long as expenditure did not exceed €62,500 - all individual projects had to be approved in advance by Cobh Municipal District.

An outline list was developed in November 2018 and this was included for public comment in the Community Expo held in the Centre in January 2019. The very popular Japanese bridge idea (Ashbourne Pond) ultimately proved to be too expensive - the total grant could easily be spent on this one project. The walkway in the Crompane Park was under budgeted and absorbed most of the bridge grant money. The mural on Harper's island entrance wall had to be relocated to the Railway Station to avoid having to get planning permission.

Work got underway with the townland stone markers along the old N25 in 2019. Seven townlands were designated and carved limestone were installed by Edward Sheedy, stonemason, Youghal Road, Midleton. They were erected on the roadside where the townland boundary intersected with the southern side of the road. The seven townlands from east to west are: Killahora Harper's Island Johnstown Lackenroe Ballynaroon, **Ballyhennick &** Kilcoolishal.



Planters were located between the Railway Bridge and Johnstown. These have added attractive and eyecatching splashes of colour.





Crompane Park was developed with a gravel pathway, three seats and lots of measures were taken to promote wildflower growth.



There was a Wildlife Mural completed inside the shelter at the Railway Station by local artist Maeve O'Keeffe. Many stone walls were renewed including a stretch at the end of Craig's Field.





A comprehensive map of Glounthaune was designed. It has been erected near the tree in the church car park.





The striking stainless steel sculpture with the wild bird theme was erected recently near Johnstown, completing the Village Enhancement Scheme measures. The piece is by the renowned sculptor John Coll who has earlier made the iconic canal-side Patrick Kavanagh and more recently the bronze Luke Kelly statue.

The Village Enhancement scheme has made a very positive impact on the visual fabric of Glounthaune and the approaches. The project was planned and co-ordinated by Glounthaune TidyTowns who deserve the highest praise for significantly adding to the pleasant environment of Glounthaune.



Earlier this month, a new publication to mark the conclusion of the first phase of the All-Ireland Pollinator Plan 2015-2020. 'Working Together for Biodiversity: Tales from The All-Ireland Pollinator Plan 2015-2020' was launched. It highlights positive action for nature across the island and shows the big difference that small actions can make.

The booklet brings together a selection of case studies to tell the story of how communities, farmers, schools, businesses, local authorities and many others have contributed towards the conservation of Ireland's pollinators.



The All-Ireland Pollinator Plan 2015-2020 has achieved considerable impact:

• The last five years have seen the delivery of almost all of the 81 actions identified in the Plan

- Across all sectors, the number of engaged individuals and organisations continues to increase
- 55% of all Councils across the island have become partners
- Hundreds of local communities have embraced the initiative
- 280 businesses have come on board and agreed to take action

• A framework by which all farms can become more pollinator-friendly is currently in collaborative development

TidyTowns Grant Funding 2020



On December 24th last, Minister For Rural and Community Development Heather Humphreys announced funding of €1 million for TidyTowns groups to help them to prepare for the 2021 SuperValu TidyTowns competition. This allocation will provide €1,000 for every eligible TidyTowns group in the country.

We are very aware that so many groups have suffered financially during the pandemic. Not being able to hold your normal fundraising events has been very difficult and the generous sponsorship given by local businesses has in many cases not been there as many of these business themselves are struggling to keep going, also greatly affected by the pandemic. We need to keep our towns and villages in business by keeping our business in our towns and villages. Remember; Stay Local, Search Local and Shop Local.

The funding announced by the Minister is in addition to €1.4 million allocated to these groups at the end of 2019. This funding will help to prepare for the 2021 competition.

In total, there are 987 eligible TidyTowns groups registered across the country. Pobal will be administering the payment of this grant on behalf of the Department of Rural and Community Development. In light of the current restrictions as a result of COVID-19, Pobal will be communicating where possible with eligible groups via email. It would be desirable therefore, if groups could submit their form electronically rather than going to a post office.

As the closing date of February 28th is fast approaching, we would encourage all groups who are eligible for this funding and who have not yet sent in their application form to submit an application immediately.

This announcement brings the total amount of funding issued to TidyTowns groups by the Government of Ireland, through the Department in recent years to €5.2 Million.
